# SC/BIOL3140 4.0 Advanced Biochemistry and Molecular Genetics Laboratory Fall, 2019

#### Course Description

Research techniques used in fundamental biochemistry and molecular biology, including recombinant DNA technology, are explained, illustrated and performed in lab. Purification of a restriction endonuclease; isolation and mapping of bacterial plasmids, bacteriophage and recombinant molecules; polymerase chain reaction (PCR); nucleic acid hybridization. Enrolment restricted. One lecture hour, six laboratory hours two days per week. One term. Four credits.

Prerequisite or corequisite: SC/BIOL 3110 3.00 or SC/BCHM 3110 3.00. SC/BIOL 3130 3.00 or SC/BCHM 3130 3.00 strongly recommended as a prerequisite or corequisite.
